# RACE BIB CONTEST

(THE "CONTEST")

## OFFICIAL RULES AND REGULATIONS

### CONTEST PERIOD:

Contest opens on June 17, 2019 at 8:30 a.m. MST and closes on June 21, 2019 at 6:00 p.m. MST (the "Contest Period").

### Who Can Enter

1. The Contest is open to all legal residents of Canada (excluding Quebec). You are not eligible to enter if you are (or you live with) an employee, officer, director, representative, agent, consultant or supplier of FAB Events Inc., or any of its respective parent companies, subsidiaries, affiliates or licensees (including Essex Lease Financial Corporation, Charlesglen Toyota, Calgary Health Trust or Heritage Park). The Contest is subject to all applicable federal, provincial and municipal laws and is void where prohibited.

Entries that contain false, misleading or inappropriate information may be disqualified at the sole discretion of FAB Events Inc.(defined below). Entries must be received prior to the Contest Period close date of June 21, 2019. Entries received after the Contest Close Date are ineligible and will not be included in any of the Prize draws.
